### PRESENTATIONS

#### 1. Recreation Advisory Committee

Charlene MacLennan, Chair of the Recreation Advisory Committee, began the Power Point presentation and spoke to Council about the Committee's role and focus. Ms. MacLennan spoke about the outdoor and indoor spaces for recreation in the City of Cornwall and of the Committee's commitment to its citizens for accessible facilities. Ms. MacLennan went on to speak about the newly constructed Aquatic Centre and the events held at the pool.

Frances Spagnola, Committee Member of the Recreation Advisory Committee, indicated that the Committee had looked at alternate venues for the skateboard park but indicated that the park will remain at its current location of Optimist Park. Ms. Spagnola explained the Committee's involvement with community groups in creating the Ice Allocation Policy and the Committee's plan to follow the same process for a new Baseball Allocation Policy. Ms. Spagnola went on to speak about other programs available to the citizens of Cornwall such as the Leisure Arts Program and ski and snowboard activities at the Big Ben Recreation Centre.

That Council endorse the Resolution made by The Regional Municipality of York and send its full support in urging the Government of the Province of Ontario and the College of Physicians and Surgeons of Ontario to take immediate action towards recruiting, training and removal of barriers restricting qualified medical trained physicians within the Province of Ontario.

## **5. Veteran's Club Tax Exemption**

On June 10, 2002, Council authorized a 50 % taxable exemption of the four Service Clubs identified as The Legion Branch 297, Navy Veterans Association, Army, Navy and Air Force Association and the Royal Canadian Air Force as permitted under the Municipal Act R.S.O. 1990, Section 207 (62) for a maximum period of five years beginning in the year 2002 and completed in 2006.

That Council refer the request made by the Veteran's Club to extend the exemption for a further five-year period ending in 2011 to Administration for report.

## **6. Youth Service Corps**

On May 31, 2006, the Youth Advisory Committee unanimously supported a Youth Service Corps in the City of Cornwall and is looking for Recreation Services to look into the feasibility of an action plan and to advise how the Recreation Advisory Committee can help in launching this program.

## **7. Planning Advisory and Hearing Committee**
